VII. Personal Interview

Upon completion and submission of the application and supporting documents, a member of the Youth in Construction Committee will contact you to schedule a time for a personal interview. This will allow for the committee to get a better understanding of your intentions and desires in the program in which you have chosen to enroll.

Rules and Requirements:

Eligibility:

- Seniors in High School, students in college (freshman-juniors) or ISA member employees entering further construction training
- Focus is on students who wish to enter a construction-oriented program
- Student must be a U.S. citizen or documented permanent resident of the U.S.

Criteria After Scholarship Awarded:

- Student must maintain a cumulative 2.5 GPA (based on a 4.0 scale) or equivalent
- Student must enter an accredited trade program, 2-year or 4-year college or university
- Student must provide evidence that the degree program they are pursuing indicates focus in an accredited construction-related academic program.

Amount of Scholarship Awarded:

- Amount of Scholarship to be a maximum of \$4,000, paid out in increments of \$1,000 per year
- ISA will award a minimum of one \$4,000 scholarship per year
- Scholarship to have a 5 year expiration date (i.e., if not used within 5 years, funds will revert to ISA for general use or use toward other scholarships)
